The agency provided the opportunity for the development of young people through friendship with a responsible female adult volunteer, as well as counselling, residential care, group activities and life skill training. In 2009, Big Sisters of London merged with Big Brothers of London to become one unified organization under the name of Big Brothers and Big Sisters of London and Area.

Administrative History

The London Battered Women's Advocacy Clinic evolved from preliminary research conducted by Constance Backhouse, law professor at The University of Western Ontario, and research conducted by her students in 1979-1980. Funded with a demonstration grant from Health and Welfare Canada, the Clinic opened on February 14, 1983. Providing individual and group counselling to women who had suffered physical assault, sexual abuse, financial deprivation or mental abuse, the Clinic also operated public and professional education programs, provided information on available resources, and conducted research to demonstrate the effects of family violence on women and to identify gaps in services to abused women. Since 2001, the Clinic has operated as the London Abused Women's Centre.

Scope and Content

Administrative History

Incorporated under the Corporations Act in April 1983, Nokee Kwe Occupational Skill Development's objective was to provide life skills and employment training for native women in London. The corporation initially provided a 26-week program of life skills classes, technical training, a career awareness program, and an external work experience. With funding from various government programs and revenues generated from its production shop, the organization provided bindery, post-printing and finishing, and sub-contracting services. Currently, Nokee Kwe offers a career assessment, planning and employment program, as well as basic educational and literacy services.

Scope and Content

Series consists of records relating to the incorporation, governance and operations of Nokee Kwe. Included are letters patent, by-laws, resolutions, accounts payable records, personnel policy and correspondence, premises leases and correspondence, correspondence to N'Amerind regarding the transfer of assets, promotional materials and general notes.

The organization was disbanded in 2000.

Mary McKim was born June 6, 1926, in Jinan, Shandong, China to Dr Ernest Struthers and Margaret Walks Struthers. She graduated from the University of Toronto with a degree in medicine in 1949, and was certified in psychiatry in 1969. During her professional career, she was involved in clinical work and teaching at the Christian Medical College in India, served as Consultant Psychiatrist at Victoria Hospital, practiced at St. Thomas Psychiatric Hospital, and maintained a private psychotherapy practice from 1982 until her retirement in 1995.

As well as membership in a number of professional associations, Mary served on the national board of the Canadian Association for Repeal of the Abortion Law (later the Canadian Abortion Rights Action League) and as president of the London chapter, was a charter member of the London Status of Women Action Group, assisted in fund-raising campaigns for Women's Community House, was a founding board member of London Battered Women's Advocacy Clinic, and has been a board member of the London Women's History Group since 1999.

In 1950 Mary married pediatrician Dr John McKim, and together they had five sons. Mary divorced John McKim in 1976, and married Douglas MacKenzie later that year.

As part of its outreach and educational activities, Womanspirit provided travelling exhibits, seminars and workshops; produced the periodical *Spirale*; added a resource centre in 1980; and opened a gallery that provided a forum for women's art. In later years, Womanspirit's emphasis turned from academic research to a concentration on the gallery. After failing to file proper documents with the federal government, Womanspirit was dissolved in 1986.

Biographical Sketch

Pat Chefurka was born in Manitoba in 1924. She received a Bachelor of Science degree from Brandon College and became the first woman to receive a Master's degree in physics from Montana State College. She taught in a London high school from 1956 to 1962, and accepted a position teaching in the Physics Department at The University of Western Ontario in 1963.

Pat became actively involved in politics during the 1940's when she became a member of the Co-operative Commonwealth Federation (CCF), and spent a great deal of time with Tommy Douglas, then the premier of Saskatchewan. In 1963, Pat ran as a New Democratic Party (NDP) candidate in the provincial election for Middlesex South. In 1964, she was elected president of the London and Middlesex Ridings Association and became the Provincial Executive of the Ontario New Democratic Party. In 1965 she ran in the federal election in Middlesex West. Pat remained heavily involved in politics and organized Ken Bolton's campaign in Middlesex South. In the early 1970's she was a provincial candidate for Middlesex North as well as campaign manager or organizer for Ray Funk, Jane Bigelow and Irene Mathysen. She served as Vice-President of the Ontario NDP and as chairman of the Provincial Resolutions Committee, and was the first woman president of the Ontario NDP.

Pat met her husband Dr. William (Bill) Chefurka, a biochemist, while attending Brandon College. They were married in 1946 and together had three children: Paul, Tannis and Cara.

Administrative History

Women's Workshop was established in 1974 in response to an expressed need by women in London for alternate learning opportunities. It offered non-credit workshops at The University of Western Ontario and Fanshawe College. At Fanshawe, Women's Workshop developed and implemented the Everywoman's Education Centre and launched the first certificate courses in Women's Studies in Ontario. In 1977, Women's Workshop began sponsoring its own education programs and a number of additional learning projects both within the city of London and throughout Southwestern Ontario. It was a non-profit organization designed to stimulate learning opportunities for women in London and Southwestern Ontario. An alternative to traditional educational programs, it was designed to create a community of women, to foster emotional and intellectual connectedness within and with other women, to build upon own experiences of life and work and to struggle with and seek answers to questions. Women's Workshop was dissolved in 1993.
