## Papers of John Law, Bell founder, Inventor of various 0il related innovations, London, Ontario

In order to improve access to more of the existing holdings of Western Archives copies of a number of preliminary finding aids are being made available. These preliminary finding aids, some of which were prepared many years ago, vary in degrees of completeness, detail and accuracy. Some provide only basic box listings of the contents of a fonds or a collection, while others provide additional background material. All are intended to be the starting point for access to the records and they should not be considered a definitive source of information on the full nature and contents of the fonds or collection. John Law was born in Leeds , England in 1821 . ( according to information from Industries of Canada and the back of a photograph in the collection labelled " Witnesses at the Trial ".... ). Les Bronson's article on John Law provides further details on his life and is in the case file . Law's death date has not yet been ascertained and he may have moved either to New York to his son-in-law's , T.B. Cryer's ( he is listed as a London Old Boy and photographed in the family photos ) or perhaps to his property in Currie. His daughters' deaths, Bessie and Louise are documented in administrations in the 1920's which John Law ( presumably his son ) applied for according to Middlesex County Administrations data. His son, John S. Law is listed in the city directories during the 1890's as being a fireman with the railways . Other John Laws appear in the city directory- particularily those listed at Horton Street. The John Law who was the Bell founder lived at 121 Clarence street. This listing continues until 1915 and a listing for John Jr. continues until 1917. However, these may be listing for John Law's son , John and a possible, grandson, John Law as well as by 1915-John Law would have been 94 years old. There is not administration for John Law or will listed in Middlesex County documents during the relevant period- 1890 to 1930. His grandson, is probably the John Gordon Law Cryer photographed in the collection along with this probable son-in-law, T.B. Cryer in New York. There is also a letter from a J. L. to Master Gordon Cryer written in 1906.

The Papers of John Law have been re-organized from the time they were received by Fanshawe. A preliminary checklist prepared by the Fanshawe is included in the case file. Tick-marks are beside those items listed that were actually located in the collection is were found unlisted and others listed were unlocated in the collection when it was catalogued in Mugust, 1982. Fanshawe deposited the records here in the Fall of 1981.

Current listing and organization is an attempt to reconstruct "respect des fondss"—all materials related to one thing have been placed in the same folder - and labelled and listed. Chronological order has also been followed within each folder. The listing follows the patterns and related documentation, technical material related to inventions, financial documents, property matters, ( with milita papers and photo ), business cards, Letters, Photographs, and Miscellany.
