In order to improve access to more of the existing holdings of Western Archives copies of a number of preliminary finding aids are being made available. These preliminary finding aids, some of which were prepared many years ago, vary in degrees of completeness, detail and accuracy. Some provide only basic box listings of the contents of a fonds or a collection, while others provide additional background material. All are intended to be the starting point for access to the records and they should not be considered a definitive source of information on the full nature and contents of the fonds or collection. Administrative History

The London Housing Commission was created in 1919 after appointed to bring the municipality under the Ontario Housing Act 1919, under by-law no. 5889. The Commission was on passed April 21, 1919 by Mayor C.R. Somerville, and City Clerk S. Baker. The full name began as "The Housing Commission of the Municipality of the City of London." The head of the Council of the Municipality in 1919 were J.G. Richter and D. Wright who would serve for two years. Thereafter, members of the Commission other than the head of the Council were instructed hold office for two years. E.R. Dennis and J.W. Cunliffe were appointed to hold office for the Commission for the first year. The Director of the Housing Commission was Mr. Ellis.

City Council carries out both legislative and administrative functions by developing policies and adopting by-laws and resolutions with respect to regulating housing quality and supply for civil servants. It is thought that the continuation of the Commission is related to the later established London Housing Authority, which was the City of London agent within the provincial entity, the Ontario Housing Corporation. It administered all rent-geared-to-income accommodation for low or low-to-moderate-income families and senior citizens, and maintained a list of those in need of subsidized accommodation.

The object of the Act was to foster house building and it was not intended that the funds should be used to buy houses already built. The Commission was stated to "not loan at all to persons who are not able to pay their way - the Act is designed to help the man who helps himself."
